



FROM THE CEO - Leo Barlow

Greetings Shareholders of Tyonek Native Corporation,

We hope this finds you and yours safe and in good health. The world as we all knew it has changed substantially in 2020 as the global Covid-19 pandemic continues to impact all of us in our daily lives. Ironically, in 1918 the Spanish Flu epidemic blighted the earth with eerily the same kind of impact. Especially hard hit then were Alaska Native Communities, including those in the Cook Inlet Region near our home village of Tyonek. In fact, many survivors of that plague settled in Tyonek when their villages could no longer function as sustainable communities often leaving only orphans to fend for themselves as the impact on adults was far worse. The same strengths that guided our people then give us guidance now as we navigate the changes brought about with the current pandemic.

Tyonek Native Corporation is fortunate that we continue to operate all of our businesses at all of our locations unlike many other companies that have been forced to shut their doors. Many of these companies will not reopen as they have exhausted all resources and have nothing remaining to restart. Because we are considered an essential business critical to the Nation's defense, we have been able to continue our business recovery plan that started in 2017. Recently, your Board of Directors declared a distribution which was made to Shareholders of record earlier this month. This is an indication of our road to recovery which is forecasting a profitable year in 2020.

These changes to the way we operate will also translate into a new way of conducting our Annual Meeting for the year ending 2019. TNC will hold a virtual shareholder meeting using electronic media that will allow shareholders to participate online in the informational and election process. The Annual meeting has been scheduled for August 22, 2020. Proxy materials and information about the Virtual meeting were mailed to Shareholders the last week in July. Many other Alaska Native Corporations have held or will be holding similar virtual meetings as gatherings of large groups are discouraged and not allowed in many jurisdictions in order to prevent the spread of the virus. While most of us would prefer to meet in person to transact the business of the company, it is not feasible given the current situation we find ourselves in.

I wanted to take a moment to also remind shareholders that if you have not already done so, please take the time to complete the US Census survey you should have received in the mail earlier this year. Every decade the Census is taken to update information about population dynamics. This information is then used by the government to allocate resources across the country in the appropriations process. It is critical that each of us complete the census to be sure our communities receive a fair share of government funding for various programs such as health care, infrastructure development, and resource development for economic growth.

Indeed these are trying times for all of us, but again our core strengths will see us through this as it did our ancestors in the past. Stay safe everyone, follow the recommended guidelines in your area, practice good hygiene and stay within your "bubble" as we move forward together.

RECENT WINS


The Business Development team has been hard at work in winning new business and rewinning existing contracts. Some recent highlights include:

- Tyonek WorldWide Services, Inc. won a contract to provide aviation maintenance support services to the U.S. Army's Redstone Test Center. The contract is valued at \$102 million.
- Tyonek Global Services, LLC won a contract to provide cyber operations support and training to the U.S. Air Force. The contract is valued at \$14.8 million.
- Tyonek Global Services, LLC was also successful in re-winning the U.S. Navy's Fleet Readiness Center Southeast contract to provide aircraft maintenance services. The contract is valued at \$107 million.

FOREST INVENTORY VERIFICATION

Field crews will be flying into the Tyonek area via helicopter direct to the Tyonek Lodge where they will begin field verification of the forest inventory plots measured during the summer of 2019. The project is expected to take up to 10 days. To comply with CDC, State and local guidelines for travel to Alaska and Tyonek respectively, field verification crews will be tested for Covid 19 once they arrive in Alaska, and on confirmation of a negative result will travel directly to the Tyonek Lodge. No interaction with the Native Village of Tyonek or locals is expected to take place unless in the event of a medical emergency in which contractors may need the assistance of the Tyonek Health Clinic. Expect to see crews operating on ATV, truck and helicopter during this time. As always, questions can be directed to the Lands Department at 907-272-0707.

TYONEK VILLAGE VIRUS TRAVEL UPDATE

The Native Village of Tyonek IRA Council has met and have implemented new travel procedures:

PRE-TRAVEL:

Before you plan and schedule a flight to Tyonek you will need to contact the Village Indian Creek Health Clinic for the screening questionnaire at 907-583-2461 and speak with any health aide, they will follow the CDC recommended screening protocols.

The health aides will then order your test to be done in Anchorage after your screening questionnaire, then will call you back when it has been approved and will give you direction on the location to get the swab test done. After you receive a negative result back, you should immediately schedule your flight with Spernak for your return. The Council President will also be informed of your results, so that he may give the ok for travel.

If you test positive for the COVID-19 virus you will not have permission to return to Tyonek.

POST-TRAVEL:

Upon arrival in the Village, tribal members will:

- * Be expected to follow the Village quarantine requirements
- * Monitor for symptoms in coordination with the Village clinic health aides
- * Report new symptoms to the Village clinic immediately

After your return you will need to self-quarantine yourself and the entire household in which you are staying in for a minimum of 14 days, you and household members will need to do a COVID-19

test on the 14th day of your return, Tests will be done outside of the clinic, be sure to call the clinic prior to your arrival for directions on what to do and where to go. You cannot go out until your test results have been received with a negative result.

Thank you all for your cooperation, and please follow the quarantine rules and social distancing, wash your hands regularly, cough into your elbow, wipe down your groceries with Clorox wipes or Lysol once you receive them.

WHAT DOES OUARANTINE MEAN?

In further detail, it means you CANNOT go out to public places, such as; Post Office, Tribal Center, TNC Office, School, Clinic, Health Department, or in anyone's house, etc.... You CANNOT also have any visitors in your residence in which you are quarantining in. If you are staying with someone in their house, those people in that household will also have to quarantine and CANNOT do the above mentioned. YOU MUST ADHERE TO THESE RULES, it is for the safety of you and others, as we have mentioned those with high risk factors. However; you may go walking and riding in your own vehicle alone to get out of your house, but there is to be NO CONTACT with others at a 6 to 12-foot distance, and always wear a mask. We may be getting masks to hand out soon for members, we will post notice when we receive them.

Thank you all for your cooperation and understanding of the severity of this COVID-19 virus and helping us to protect our people.

COVID-19

 - Wash your hands frequently with warm,


- soapy water for at least 20 seconds.

- We are staggering break and lunch times to better facilitate the practicing of social distancing.
- We have staggered shifts at some locations to allow better social distancing.
- We have implemented strict visitor policies and eliminated all nonessential visitors.
- We have provided masks and hand sanitizer
- We have eliminated nonessential travel.
- We continue to offer the use of liberal leave as an option available to all employees. Employees can use earned PTO, Vacation or Leave Without Pay during this time.

As always, the health and safety of our employees is our top priority.












































Did You Know?

DISTINCTION BETWEEN THE AND NVT

There is no legal relationship between TNC and NVT. Tyonek Native Corporation (TNC) is a state chartered, for-profit Alaska business corporation that was formed in 1973 as part of the Alaska Native Claims Settlement Act (ANCSA). Members of TNC are Shareholders of the corporation. The federally recognized tribal entity for the community of Tyonek is the Native Village of Tyonek (NVT). NVT was organized in 1939 under a federal law called the Indian Reorganization Act. 25 U.S.C. 461 et. seq. Members of NVT are Tribal Members. TNC and NVT are separate and legally distinct entities with no formal legal relationship. People from Tyonek may be both a shareholder of TNC and a tribal member of NVT.

ANNUAL MEETING

Due to the COVID-19 pandemic, the TNC Board of Directors has decided to hold the Annual Meeting virtually. It will be on Saturday, August 20th. You've received information regarding the meeting, how to join, and how to cast your ballot. While we would much rather all meet together, we feel this is the best course of action to ensure the health and safety of our shareholders.

COSTS OF VANDALISM

Subsistence is Our Agriculture



I hope that you're all staying healthy and safe during this uncertain time. The COVID-19 pandemic has changed our world, and like all of you we are doing our best to adapt individually and as an organization.

TTCD's mission and programs are more meaningful than ever today. Everything that we do supports food security, and that's especially important now. To ensure the safety of our community, we are modifying our programs while we continue to deliver them. Our staff and board are working hard to develop innovative approaches and I am confident that this will result in our best work as an organization.

Each year, the Tyonek Grown program provides fresh, local produce in Tyonek to reduce reliance on outside food sources. With a global pandemic, having this local food source is essential. In 2020, TTCD is using new distribution methods to increase safety and availability.

The Elder's Lunch program continues to be the first priority for Tyonek Grown veggies. This year, with the generous financial support of Tyonek Native Corporation, TTCD is providing vegetable boxes to households in Tyonek at no cost to the customer. In June we conducted a sign up and a raffle, and in July began providing bi-weekly veggie boxes to six

families. As we begin to harvest more vegetables later in August we will begin providing veggie boxes to additional families. All of this was done through the dedication of the Tyonek Garden staff, including Garden Manager Gwen Chickalusion and Assistant Garden Manager Dominc Moon, as well as the five youth interns hired for the 2020 season: AJ Allowan, Alicia Smoke, Joyce Trenton, Reka Smoke, and Steven Standifer. In 2020, TTCD and partners completed a culvert replacement on a tributary of Old Tyonek Creek on a fish camp road in Tyonek. The project opened 1.2 miles and 19 lake acres of upstream habitat that was previously blocked to juvenile and adult salmon. The new culvert will also prevent this road from washing out in the future.

TTCD staff are working on several other projects in 2020 to support healthy salmon habitat and populations. We completed stream habitat improvements and added an overflow culvert at a crossing on Indian Creek in Tyonek. We are also working closely with the Native Village of Tyonek Environmental Department and other partners to continue to address invasive species, including


pike, elodea, orange hawkweed, and other invasive plants. TTCD Biologist Jillian Jablonski worked with Brian Peter (NVT Environmental Department) to removed 160 pike so far this year.

For the 2019-20 school year, TTCD partnered with the Alaska Department of Fish & Game and the Tebughna School to bring the Salmon in the Classroom curriculum to Tyonek. Starting in the fall, Tebughna School students raised and observed baby salmon from eggs in a classroom incubator. When students were no longer in the school, Tebughna School teachers took on the task of caring for them. As mandated in the ADFG permit, these salmon needed to be released into a Kenai Lake, and on May 7, the baby salmon were flown across the inlet and set free!
